## GUA Africa

### Report of the Trustees for the Year Ended 30 April 2020

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 30 April 2020. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

#### **OBJECTIVES AND ACTIVITIES**

##### **Objectives and aims**

The objectives of the charity are for the benefit of people living in Sub-Saharan Africa, by:

1. The advancement of education for the public benefit by providing and assisting in the provision of facilities for education.
2. The relief of financial hardship, in particular but not exclusively by the provision of education and vocational training.
3. The relief of sickness and preservation of good health by providing or assisting in the provision of equipment, facilities and services.
4. The relief of need of persons in areas of conflict or affected by conflict, in particular children and young adults.
5. The relief of need of orphans by providing or assisting in the provision of items, services and facilities.

##### **Our Mission**

Our mission is to work with individuals, families and communities to help them overcome the effects of war and poverty.

##### **Public benefit**

The trustees have paid due regard to the Charity Commission's guidance on public benefit in deciding what activities the charity should undertake. The trustees consider that they have acted in the public benefit.

##### **Strategic Objectives of Our Projects**

###### **Survivors of War Project**

Facilitate the ongoing sponsorship (from individual sponsors) that enables the young adults to go to school/college/university.

Provide emotional support to the group (in loco parentis).

Provide accommodation for all students where required.

Assist in the transitions from the programme into employment, and assist with arrangement of internships where necessary as part of their studies.

###### **MyStart Project**

My Start is an educational Creative Arts project in partnership with GUA Africa which provides Art and film workshops in Kakuma Refugee Camp, Kenya and the work produced at the camp is then exhibited in UK schools.

**My Story** - The workshops enable young refugees to express themselves in a fun and dynamic way, as well as reflect upon their experiences and challenging circumstances through education and the Arts. The exhibitions allow these stories to be shared and acts as a powerful, visual resource in the camp and UK schools.

**My Art** - Creative learning is integral to all young people's social and emotional development. Art celebrates and values the individual. This is particularly important for displaced people trying to reclaim their sense of identity and purpose that has been lost in the abyss of war and suffering.

### Report of the Trustees for the Year Ended 30 April 2020

#### **ACHIEVEMENT AND PERFORMANCE**

##### **2019-20 Activities and Performance**

Gua Africa provides educational programs for those affected by war and displacement in East Africa. We work primarily in Kenya offering education to refugees who have survived war and genocide. We believe that an inclusive and holistic approach to education is key, especially in communities where young people have been cut off from mainstream schooling.

Our programs offer academic scholarships to refugees, as well as a range of comprehensive, purpose driven initiatives which promote creative wellbeing and leadership in order to address more sustainable solutions for peace and independence for our young beneficiaries.

Our work focuses on the world's newest country South Sudan, and with the victims of its long running civil war as part of Sudan throughout the 80s, 90s and 00s. Due to the continued civil unrest and insecurity, we have been unable to continue with our school building programme, and now our focus has been on supporting young survivors of war to complete their education, outside of South Sudan. In addition to this we now provide educational creative arts opportunities directly to those still displaced and living in Kakuma Refugee Camp, Kenya. Refugees in this camp have predominantly fled from conflict in Southern Sudan but it also supports those affected by war from the Congo, Rwanda, Burundi, Somalia, Uganda and those affected by poverty from the host community from Kenya living in Turkana. The artwork from our projects has been presented and exhibited to over 20 schools in the UK this past year and used as an advocacy tool for a large exhibition and fundraiser at Dulwich College, London for students to learn and connect more with refugees, through their own expression. Workshops have also been conducted so that students in the UK can learn and respond to the Art and Films and this has been taken back to the camp as a means by which refugees living in Kakuma can connect to young people in the outside world.

We were absolutely thrilled to be selected as M&C Saatchi's chosen charity for 2019.

As a small grass roots charity this partnership provided us with support in 4 key areas, harnessed with the talent of leading professionals from an international communication agency.

- Media training workshops in Kakuma refugee camp
- Marketing and branding for the charity
- Fundraising initiatives and donations from the business
- Long term funding ideas for partnerships

After an initial grant of £5,000, M&C hosted a plethora of fundraising efforts with a dedicated committee including; bake sales, a 5 a side football tournaments, raffles and quizzes. Some of the ideas were completely ingenious and others were individual initiatives for example a weekend brunch or an individual organising a team half marathon run. These events were a constant source of amazement from the generosity of everyone, and culminated in raising £12,800 in total.

As well as raising awareness of the issues faced by refugees and communities we work directly with in East Africa, in October 2019 three members of the M&C Saatchi team joined My Start in Kakuma and ran workshops on professional skills, film and media.

My Start ran a number of London based events through 2019 with exhibitions and workshops in schools across London as well as hosting two flag ship exhibitions, the first in June for Refugee week at The Sari Project and a second exhibition and event including key note speakers at 'The Africa Centre' in October 2019. M&C Saatchi supported this event with the exhibition also open to the public and for schools with workshops for two weeks which was also covered by BBC Africa.

Gua Africa also raised over £3000 in December 2019 as part of 'The Big Give' for Windle International as part of our partnership work with vocational training programs in Kakuma.

We have further progressed the charity's identity and profile launching a new logo and website at the start of 2020. The branding and identity was designed voluntarily as a donation to the charity by D&AD award winning designer Gene Cooke from Hackmanpitneywilder. This was necessary to both raise our profile for future partnership work and fundraising, and to ensure our new vision and goals are spotlighted for existing advocates, friends and supporters, as well as attracting a new audience. We have continued to build on our school network particularly in the UK and through our partnership network with Dulwich College. Dulwich College is an Independent school in the heart of London and part of Dulwich College International School Group (DCI). It is also in a partnership group with 18 UK London based schools. This partnership is multi-faceted and brings opportunities to Gua Africa through their educational expertise across a wide range of both academic and pastoral matters, as well as the ability of the College promoting Gua with their partner schools and wider community. Dulwich College has an impressive scholarship and bursary program with over 30% of their pupils already receiving benefits and a vision to increase this to 50%. Gua can benefit from working with the College on how this program is run and the rigorous systems of application, interview and testing as well as the support in place for scholarship students both academically and pastorally.

Our new structure and vision comprises of five pillars under two interweaving headings, Education and Well-being. Our Education programs includes three pillars, Survivors of War program, Vocational training, our school vision for the future. This works in tandem with our Well-being programs 'My Life is Art' and My Start project. <https://www.gua-africa.org/>

Further to this we will begin building on our scholarship provision and processes to enter the program. This will include working with our partnership schools in the UK in particular Dulwich College, and also Kenya Nairobi. We are currently seeking partners in Kenya including Brook House where Emmanuel Jal was a pupil. Our core aim is to establish a rigorous, inclusive, fair and wide-reaching application and interview process for scholarships.

We will be working on our recovery plans from COVID and our primary goal is to support our final graduates from the programme - many who will be returning to South Sudan or will be moving into employment. We will be taking on new students, developing our vocational offering and introducing a new financial literacy programme for our students based in Nairobi. We will be reviewing and refining our admissions criteria in response to our new vision and goals -whilst completing our growing team connected to our founder Emmanuel Jal who can establish new funding opportunities and strategies.

All administrative tasks are now currently being undertaken on a voluntary basis by the trustees, with the exception of the local programme coordinator based in Nairobi our newly appointed Irene Tunya who replaces Adams.

#### **FINANCIAL REVIEW**

##### **Reserves policy**

A formal reserves policy was agreed at the 12th May 2012 meeting of the executive committee.

At 30th April 2020 we had reserves of £4,509, and a cash balance of £5,977. We remain committed to having a small amount of reserves in place. As we do not pay for administrative support here in the UK, our overheads are very small and this minimises any risk of debts being accrued.

##### **Going concern**

The trustees acknowledge that the charity had very low reserves at 30 April 2020. Since the year end the reserves have continued to improve. The trustees confirm that the going concern basis is considered appropriate.

#### **STRUCTURE, GOVERNANCE AND MANAGEMENT**

##### **Governing document**

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

##### **Recruitment and appointment of new trustees**

Emmanuel Jal is the founder of GUA Africa and he approached the other two initial trustees who assisted in the process of the charity registration. The existing trustees of the charity are responsible for the appointment of any additional trustees.



**1. ACCOUNTING POLICIES**

**Basis of preparing the financial statements**

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The financial statements are prepared on a going concern basis, under the historical cost convention, modified to include certain items at fair value. The financial statements are prepared in sterling which is the functional currency of the charity and rounded to the nearest pound.

There are no significant areas of judgements or key sources of estimation uncertainty.

**Going concern**

The trustees acknowledge that the charity had very low reserves at 30 April 2019. Since the year end the reserves have improved. The trustees confirm that the going concern basis is considered appropriate.

**General information and legal status of the charity**

Gua Africa is a company limited by guarantee and has no share capital. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the charity. The registered office address can be found in the Trustees' Report.

**Financial reporting standard 102 - reduced disclosure exemptions**

The charity has taken exemption from preparing a cash flow statement under the charities SORP (FRS 102) Update Bulletin 1 issued on 2 February 2016, as the charity constitutes a small charity.

**Income**

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

**Expenditure**

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

**Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Computer equipment - 33% on straight line basis

**Stocks**

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

**Taxation**

The charity is exempt from corporation tax on its charitable activities.

**Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the accounts.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

**1. ACCOUNTING POLICIES - continued**

**Debtors**

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

**Cash at bank and in hand**

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

**Creditors and provisions**

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

**Financial instruments**

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.
